| High Overview of the <u>LCAP</u> : Dr. Dustin<br>Seemann | Report submitted to the state- required by the state  |
|  | General budget- \$60-70 million dollars, only about 565k comes from the federal budget. Most of it is community funded via tax. |
|  | \$250k set aside for AirTutors, parents reported positive impact.   |
|  | As DELAC, possibility to earmark funds for family connections.  |
|  | Tutors available in home languages.   |
| Assessments & Accountability: Dr. Dustin<br>Seemann      | Normed assessment for Q1 at the high school level   |
|  | Initial ELPAC progress moving along smoothly  |
| Reclassification: Dr. Dustin Seemann                     | New reclassification criteria shared (see handout).   |

Childcare tied to EL and Title I services

DO will provide further guidance (no impact for current school year).

Joe, BVMS AP: Review **elementary report card language** (criteria says "3 or 4," but scale ends at 3).

Kim, BHHS AP: Older students reluctant to participate in pull-out interventions.

Not board policy to require support.

Ideas for improvement: Creative celebrations (e.g., cords, recognition at board meetings).

Explore alternatives for scheduling (during vs. outside school hours).

Mrs. Nathalie Virem and Mrs. Arcelia Hernandez Bahena, HM parent reps: Many EL families struggle due to limited English proficiency.

**Dustin - Adult EL Services** through the City of Beverly Hills at Roxbury Park. Day, mid-afternoon, evening classes. Resource to be shared with families and at ELAC meetings.

ELAC attendance - send flyers home in students' backpacks.

Individualized emails from ELCs introducing themselves.

Counselor involvement to support parent understanding of the school system.

High School: encourage personal phone calls to families for ELAC participation.

Translation services via phone and zoom and in person

Go beyond just emails and parentsquare—may not always translate.
