- Student's citizenship and behavior are not "satisfactory" for the current and immediately preceding semesters
- Student has not maintained an unweighted grade point average of 2.0 or better in 6th-12th. TK-5th must maintain appropriate academic effort and achievement.

___ A permit may be revoked or canceled at any time for the following reasons per the terms and conditions stipulated in BP and AR 5117:

- Student is expelled by BHUSD
- Student must uphold all school rules and applicable Education Code.
- Regular school attendance is required. Unexcused absences and tardies will be monitored according to the truancy laws in the state of California, Education Code 48260.
- Student submit an application or registration materials that contain false/misleading/omitted information.

___ Students who are eligible for Special Education services or a 504 plan must submit a current Individualized Education Plan (IEP) for review by the Student Services Department. Approval is subject to service and space availability. If approved, placement may not be at the site requested.
